**Application Deadline is October 4, 2024. Do not send any payments until you have received notification of your selection**

- If you are approved, you must provide proof of General Liability Insurance and any permits or licenses required and must comply with all State, County, and City regulations. All proof of insurance must be submitted along with payment.
- If you are selected, full payment along with proof of General Liability Insurance must be received within five (5) days of your selection. If your payment and insurance certificate is not received within the specified time, you will automatically be placed on the Waiting List and the reserved space will be offered to someone else. **Deposits or Partial payments will not be accepted.**

- All vendor spaces will be assigned at the discretion of the Event Vendor Coordinator and assigned spaces are final. **All payments are Non-refundable.**
- Vendors will receive (1) 6ft table, (2) chairs, (2) Vendor Wristbands and 2 Parking Passes per 10x10 space purchased.
- All vehicles must be parked in the designated vendor parking area no later than 10:00 am on Saturday. Any vehicles left in the vendor area after 3:00 am on Sunday, November 3, 2024, will be towed at the owner's expense.
- All Vendors are prohibited from selling any type of beverages including water at the event. Any Vendor found selling Beverages or Water will be fined **\$1,000.00** per incident which must be paid immediately, or your vendor booth will be closed down by BX MEDIA GROUP, LLC staff, Festival authorities and Law enforcement. **There will be no refunds issued!**
- **No Vendor will be allowed to sell Treasure Coast Music Festival merchandise or merchandise featuring any of the artists appearing on the festival. Any Vendor found selling these items will be fined \$1,000.00 which must be paid immediately.**



Applicant represents that he/she is fully authorized to sign for and bind the undersigned vendor to this application and agreement. Vendor agrees that vendor and all persons associated with it shall comply with all rules, policies and procedures prescribed in this application as it deems necessary for the efficient, safe, and tasteful (i.e., non-offensive) conduct of the event and related activities Vendor agrees to sell only the items described and approved in this application. Failure to do so will result in violation of the agreement and at the sole discretion of BX MEDIA GROUP, LLC. A fine may be imposed or termination of contract and removal of vendor without reimbursement of any payments made to the event. Vendor agrees to each and all clauses set forth in this agreement. Failure by vendor to abide by any clauses set forth in this agreement gives BX MEDIA GROUP, LLC. the right to (1) immediately terminate this agreement (2) require vendor, immediately upon notice of violation of this agreement, to cease operations and vacate the premises, and (3) forfeit all fees paid for the right and privilege of participating in the event.

Vendor shall not display, offer for view, or sell any illegal or contraband items. The laws of the State of Florida and local ordinances of the City of Fort Pierce Florida shall control. All vendors are also requested to not sell items considered a nuisance or inappropriate. Vendor acknowledges and understands that it is responsible for sales and Use Tax and shall in no way hold BX MEDIAGROUP, LLC, Causeway Cove Marina, or its representatives responsible. Vendor shall comply with all codes and regulations of the City, County and State of Florida. Vendor acknowledges it has read this agreement and agrees to follow all rules and guidelines as directed.

This Agreement is subject to vendor satisfactorily submitting all requested application materials, and full payment of all designated fees. It is the responsibility of the vendor to be aware of these Rules and Guidelines as well as all applicable governing laws. It shall be vendor's duty to ensure that all employees and agents of vendor are knowledgeable of and abide by all Rules and Guidelines and applicable governing laws.
